

# Practitioner License for Arvigo® Trademarks.

Completing this page grants you a license for limited use of Arvigo Institute trademarks in your business or practice as a provider of Arvigo® Therapy. There are two registered trademarks covered by this license which are the following:

- • The Arvigo® Logo (see attached, exhibit A)

This limited license is granted with the following understanding and conditions:

- • This license is granted to you as an Arvigo® practitioner (not your business or employer) having

completed Professional Care Training conducted by the Arvigo Institute.

- • This limited license runs with your membership in MAIA which you must maintain and renew to

retain the limited rights granted by this license. This license renews for a period of one year along with your membership renewal. The fee for this license is included with the membership fee in the Association. If your membership should lapse, however, this license becomes null and void immediately and can be re-instated only by The Arvigo Institute which may charge an additional administrative fee to do so.

- • You must maintain your professional license as required by the regulatory authority which governs your profession.
